

THE PASSING OF CHAIRMAN ROBERT A. CLEMENTS

It is with a heavy heart that we share with our community the passing of Cedar Point's Board Chairman, Robert A. Clements, on October 25, 2024. He was at his home with his loving family by his side.

Mr. Clements served on the Cedar Point Federal Credit Union® Board of Directors for 37 years. He was a fierce advocate for our members and consistently championed their satisfaction. After assuming the duties as Chairman of the Board of Directors in 2023, Mr. Clements remained dedicated to the interests of our members. He advocated for improved member services, including expanding member service facilities, lower consumer interest rates, and individual money management programs. He was always eager to talk with members on ary issue.

Mr. Clements enlisted in the U.S. Navy in January 1963 and had an extensive career that spanned almost 27 years, with duty on numerous cruisers and destroyers. After he retired in 2003, he remained an active community member. He was involved with many local organizations, including VFW Post 445, Moose Lodge 2393, American Lodge No.

98, Fleet Reserve Association, St. Mary's County Elks Lodge #2092, Scottish Rites Bodies, and Boumi Shrine Temple of Baltimore. Mr. Clements was also a Christmas in April volunteer, serving as House Captain for several years. Robert Clements was an exceptional leader and cared deeply for Cedar Point. He was a fixture at the credit union for nearly four decades, and his devotion to employees and members was second to none.

FRAUD AWARENESS

Fraudsters are tricky and use various tactics to separate you from your money or sensitive information. Being aware of fraud schemes currently impacting our community and how to combat them can prevent you from becoming a victim of fraud.

The most common scam fraudsters will use to compromise your financial accounts is phishing. Bad actors can gain access to sensitive information by spoofing caller ID information, emails, text messages, and websites and then ask you for sensitive or personal information like birthdates, Social Security Numbers, passwords, and multifactor identification codes. Know that **Cedar Point will never text you to tell you that there are complications with your account.**

Vigilance is the best protection against fraud. By utilizing security alerts and monitoring your accounts for suspicious activity, you can catch fraud before it causes lasting damage. If you see unusual account activity or a purchase you didn't make, report it to your financial institution immediately.

Remember, if you are contacted by someone claiming to be Cedar Point that is asking for personal information, do not respond. Instead, call Cedar Point at 301-863-7071 to verify the legitimacy of the call, text, or email. Our Call Center representatives are available Monday through Friday from 9 a.m. to 5 p.m. and Saturdays from 8:30 a.m. to noon.

MULTI-FACTOR AUTHENTICATION

Cedar Point Federal Credit Union is constantly working to ensure that our digital banking system provides members with a user-friendly digital experience and tools to help them take charge of their finances. Last year, we updated our platform to serve our members better. In addition to tools like Bill Pay and Credit Score Check, members can view pending transactions, link accounts outside of Cedar Point, and access a personal financial management tools.

We've recently enabled two-factor authentication push notifications so that members can have an extra layer of security when logging into digital banking from a device other than their phone. Two-factor authentication is a type of multi-factor authentication security method that requires two forms of identification to access an account.
