## IRA & ESA SAVINGS CHANGES

As of January 1, 2026, our IRA & ESA Savings accounts have been consolidated. There is now one Traditional IRA, one Roth IRA, and one Coverdell ESA, where previously there were two of each. The new minimum balance for all IRA & ESA Savings accounts is \$5, and the minimum balance to earn the stated APY is \$100. ## EXTRAORDINARY DIVIDEND

To celebrate our 80th anniversary and the wonderful year we have had, we gave a second special dividend to all our members in good standing in December.

We're proud to announce that we have paid over \$810,000 in Special Dividends to members this year! This extraordinary dividend was awarded to primary savings accounts in good standing in mid-December, and every account that met the requirements\* received \$10.00 to be used however they'd like. We thank our members for joining us on our journey as we continue to grow and best serve their needs.

\*To receive the Extraordinary Dividend, an account must have been open as of the close of business on December 8, 2025. The primary savings must have at least the required minimum balance of \$5 for primary savings to receive the dividend. The account must not be in active charge-off status, in the negative for 60 days or more on any suffix, delinquent on a loan, credit card, or mortgage for 60 days or more, and all account owners must not be deceased. Limited to one special dividend per account. Dividends are paid from current income and available earnings after required transfers to reserves.


